Contractors / Firms / Private Limited Company registered with Assam Tourism Development Corporation Ltd. with up-to-date registration certificate, having experience in similar nature of works are eligible to submit tender. Up to date VAT / GST clearance certificate, PAN and Deed, Power of Attorney (in case of Firms), MOU & Power of Attorney (in case of Private Ltd. Company), Upto date Labour license, Bank Solvency certificate, work order for similar nature of work with completion certificate, Balance sheet for last five years shall be furnished along with the application seeking issue of Tender Document.

3) **Tenderer Minimum Qualification Criteria:**

- i. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which Tenders are invited should be either of the following-
  - a) Three similar completed works costing not less than the amount equal to 40% of the Tender value.
  - Or**
  - b) Two similar completed works costing not less than the amount equal to 50% of the Tender value.
  - Or**
  - c) One similar completed work costing not less than the amount equal to 80% of the Tender value.
- ii. Tenderers must submit work order and completion certificate.
- iii. Average Annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be not least 30% of the Tender value.
- iv. Tenderers must submit Audited Balance sheet in support of his financial credentials, for the last 5 (five) years.

4. Tender documents may be purchased from the office of the Managing Director, ATDC Ltd. Guwahati-8, on **01.09.2017** enclosing non refundable fee as indicated in the above Table, in the form of Bank Draft or Banker Cheque of any Schedule bank payable at Guwahati in favour of Managing Director, ATDC Ltd., Guwahati-8. 5. Court fee stamp of Rs. 8.25 (Rupees eight and paise twenty five) only to be fixed with the tender document without which no tender will be considered for acceptance.

6. Tender must be accompanied by Earnest Money of the amount specified for the work in above table, drawn in favour of Managing Director, ATDC Ltd., Guwahati – 8. Earnest Money will have to be in any one of the form of KVP / NSC / FDR / CALL DEPOSIT and shall have valid for 45 days beyond the validity of the tender. (i.e. 180 days + 45 days = 225 days from the date of submission of tender) (Banker cheque / D.D. will not be accepted).

Sealed Tender must be delivered to the Managing Director, Assam Tourism Development Corporation Ltd., Paltanbazar, Guwahati – 8, on or before 2.00 P.M. on **05.09.2017** and the Tender will be opened on the same day at 2.30 P.M., in the presence of the Tenderer or their authorized representatives, who wish to attend. If the office happens to be closed on the date of receipt of the Tender as specified, the Tender will be received and opened on the next working day at the same time & venue.
