- i. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which Bids are invited should be either of the following
 - a) Three similar completed works costing not less than the amount equal to 40% of the Bid value.

b) Two similar completed works costing not less than the amount equal to 50% of the Bid value.

Or

- c) One similar completed work costing not less than the amount equal to 80% of the Bid value.
- ii. The Bidder should have average annual financial turnover 30% of estimate cost on construction works during the last three consecutive years balance sheets should be duly audited by Chartered Accountant.
- iii. Bidders must submit Audited Balance sheet in support of his financial credentials, for the last 5 (five) years.
- 14) Bidders should quote rates considering the latest Govt. order / circular / notification on G.S.T.
