Company), Upto date Labour license, Bank Solvency certificate, work order for similar nature of work with completion certificate, Balance sheet for last five years shall be furnished along with the application seeking issue of Tender Document.

3. **Tenderer Minimum Qualification Criteria :-**

(i) The Tenderer should have completed similar nature of work with value not less than 66% (sixty six percent) of Tender value of Government / Public Sector Organization in any one year for the last 5 (five) years. Completion Certificate from the competent authority must be furnished along with the application.

(ii) Annual turnover of the respective Tender must not be less than 150% (one hundred fifty percent) of Tender Value in any one year for the last five years. Certificate from CA must be furnished along with application.


