7) A hard copy of the technical bid submitted online is to be submitted on **09.03.2023** upto 2.00 PM for evaluation purpose. For any discrepancy between the online bid and the hard copy of the bid, the online bid will govern and will be considered for evaluation.

8) Bidders are advised to scan their Technical papers at 100 dpi (In Black & White mode) in pdf format for multiple pages with maximum file size of 5MB. If numbers of pages exceeds, the bidders are advised to create multiple files and upload the same in "Upload Additional Document" stage.

9) Bidders should quote rates considering the latest Govt. order / circular / notification on G.S.T.


10) The Managing Director, ATDC Ltd., reserves the rights to cancel any Bid or all the Bids submitted by Bidders without assigning any reason.

11) Bidders who do not fulfill the requirements need not participate in the Bid process.

12) At the time of participating in the bid process, each bidder must furnish a written undertaking in the form of an affidavit declaring that the bidder has never failed in making timely payment of monthly/ annual rent in the field of Hospitality, Hotel, Restaurant, Guest House, F&B services and other tourism related activity, etc. The bidder must also declare that the bidder was never adjudged as defaulter while making payment to any organization/ individual in similar nature of business. If the

bidder fails to furnish/ submit such affidavit or if any of such declaration in the affidavit is later on found to be false, then such bid shall be considered non-responsive and the ATDCL shall have the exclusive right to reject such Bid/Tender without assigning any reason. ATDCL shall bear no liability whatsoever consequent upon such a decision. No request for alteration, modification or substitution in respect of such Tenders shall be entertained by ATDCL. It is specifically stated that deliberate and malicious submission of bid with false declaration shall render such bid non-responsive, which shall be summarily rejected without assigning any reason.
