Certificate and Up to date VAT Clearance Certificate, (iii) PAN Card, (iv) Deed & Power of Attorney (in case of Firms), (v) MOU & Power of Attorney (in case of Private Ltd. Company), (vi) Completion Certificate of similar nature of work along with work order, (vii) Annual Turn Over Certificate from C.A., (viii) Balance Sheet for last 5 years, (ix) valid license for labour, (x) valid license for Anti termite work, (xi) valid license for electrical work (or tie-up arrangement with such license holder for carrying out the Anti termite work and electrical work), (xii) list of Equipments with proof of ownership, (xiii) list of key personnel with consent letter and certificate of key personnel, (xiv) list of ongoing works with work order and Engineer's certificate, (xv) work programme, (xvi) quality assurance certificate & (xvii) Bank solvency certificate with cash credit facilities etc. are to be furnished along with the application seeking issue of Bid Document for pre-qualification of the applicant. 4. Bids must be accompanied by Bid security of the amount specified for the work in above table, drawn in favour of Managing Director, ATDC Ltd., A.K. Azad Road, Paltanbazar, Guwahati – 8. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid (i.e. 180 days + 45 days = 225 days from the date of submission of Bid) and balance documents as per SBD (Vol.-1, Technical Bid) excluding document of Sl.-2, para-2.

5. A pre-bid meeting will be held on **04/02/2011** at 12.00 hours at the office of the Managing Director, Assam Tourism Development Corporation Ltd., A.K. Azad Road, Paltanbazar, Guwahati – 8, to clarify the issues and to answer questions on any matter that may be raised.

6. Sealed Bids must be delivered to the Managing Director, Assam Tourism Development Corporation Ltd., A.K. Azad Road, Paltanbazar, Guwahati – 8, on or before **14.00 hours on 08/02/2011** and the Technical bids and Price bids of technically qualified bidder will be **opened on the same day at 14.30 hours**, in the presence of the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time & venue. (Sealed Bid must be submitted before **14.00 hrs on 08/02/2011**).

8. Bidders Minimum Qualification Criteria:

- i) The Bidder should have completed similar nature of single work with value not less **Rs.35,64,000.00 for each group** only under Government / Public Sector Organization in any year from the last 5 (Five) years.
- ii) Bidders must submit work order and completion certificate along with application.
- iii) Annual turnover of the respective Bidder must not be less **Rs.81,00,000.00 for group** only in any year from the last five years.
- iv) Bidders must submit audited Balance sheet in support of his financial credentials, for the last 5(five) years along with application.

9. Bidders should quote rates considering the latest Govt. order / circular / notification on VAT.
