1. Introduction

The Assam Tourism Development Corporation Ltd, which is a Government of Assam undertaking, established in the year 1988, is inviting an “*Global Expression of Interest*” from suitably qualified consultancy firms specialised in the study, design, project management, supervision, delivery and commissioning of state of the art catamaran ferry in River Brahmaputra, Assam, India with a view to providing consultancy services for the procurement of luxury catamaran. The catamaran would be used as a ferry for tourists.

2. Summary of Key components of the Catamaran *

3. Scope of services.

(i) To review the requirements and feasibility for state of the art catamaran ferry in light of existing conditions and future development and submit a report.

(ii) To prepare the design of the Catamaran and detailed technical specifications for construction, supply, delivery and commissioning of the above equipment, with cost estimates and prepare the bidding documents in line with the provisions of the Public procurement standard guidelines of Government of India taking into consideration the environment, durability, cost effectiveness and life span.

(iii) To submit a report on post construction & operational management of Catamaran in river Brahmaputra and issues, maintenance service, spare parts etc.

(iv) To assist in the evaluation of bids received with a view to assessing their technical responsiveness.

(v) To provide consultancy services during the construction works for the Catamaran. These would include third party inspection during the construction, test/trials and commissioning stages. Furthermore, consultants will provide assistance to the ATDC during the warranty and witness final testing.

4. Time frame

The consultancy services for scope of services item no. (i), (ii) & (iii) are expected to be completed within a period of 8 weeks as detailed below:-

(i) Submission of assessment report following review within four weeks from start of the services.

(ii) Submission of draft bidding documents within two weeks after approval of assessment report

(iii) Submission of final bidding documents two weeks upon approval of draft document by ATDC.

All documents submitted will remain the property of the ATDC.

5. Eligibility

The consultancy firms should possess a minimum of Five years' experience in the study, design, project management and supervision of similar construction works and have undertaken at least complete passenger Catamaran. **However, it is to be noted that, the Consultants or firms who/which will be awarded the consultancy contract, will not be authorized to participate in the bid for construction, supply, and commissioning of the above equipment. Firms should have minimum annual turnover of Rs.1.00 crore (Rupees one crore).**

6. Technical Proposal

The Consultancy firms shall submit the following:-

- Profile of the company, its organization, staffing, and details of experience in similar assignments undertaken during the last five years including name of clients, locations, duration, and description of assignment.
- A proposal of the company's deployment schedule for undertaking the assignment.
- The list of key professional staff, with complete curriculum vitae and their working experience in similar consultancy works , to be enlisted for the assignment, which should however include, but not limited to the following:-
 - One Naval Architect
 - One Marine Engineering Specialist
 - One Electrical/Electronic Engineering Specialist
- A detailed report on all similar works / projects completed with a soft copy and photographs.
- **All testimonials and credentials should be furnished alongwith the technical bid.**
