Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid (i.e. 180 days + 45 days = 225 days from the date of submission of Bid) and balance documents as per SBD (Vol.-1, Technical Bid) excluding document of Sl.-2, para-2.

ii) Bidders must submit work order and completion certificate along with application.

iii) Annual turnover of the respective Bidder must not be less ` **1,29,05,914.00 for Group A, ` 1,29,60,411.00 for Group B & ` 1,29,58,628.00 for Group C** only in any year from the last five years.
